1st Bylaw suggestion:

Proposed Change: Strike CEO reference in VI.F.1:

VI. Officers

F. Chair

1. The Chair shall ~~be the chief executive officer of the State Party, holding~~ hold the powers of administration pertaining to the ordinary business affairs of the State Party and such other powers as may be delegated by the State Convention.

The Chair shall serve as presiding officer for meetings of the Executive Committee and the State Convention.

Reason for the Change: To resolve the confusion associated with the corporate-world term 'chief executive officer.' A term generally associated with an officer elected by a 'board of directors.' That not being the case with the LPNH Bylaws and Rules, the term can be eliminated

without requiring other significant changes.

Defining “for cause” in the removal of an officer

Proposed Change: Addition of Section VI.L.1:

VI. Officers

L. The Executive Committee may, for cause...

1. Cause shall include, but not be limited to: dereliction of duty, malfeasance, theft of or damage to state or affiliate party property, creating legal liability for the state party or an affiliate, causing ill repute of the state party, or acting in detriment to the goals and interests of the state party.

4th Bylaw Suggestion

Open and transparent EC Meetings

Proposed Change: Addition of a sentence into VII.B.3 to include the entire membership:

VII Executive Committee

B. Meetings

3. The committee shall, as part of the agenda of every meeting, set a date, time, and place for the next meeting. A notice reminding the members of the meeting schedule shall be provided to all Executive Committee members via electronic methods of communication by the Secretary at least seven days prior to the start of the meeting. Notice of upcoming meetings shall be provided to the membership via regular party communications. Except for matters to be taken in Executive Secessions, all Executive Committee meetings shall be open to the

general Membership.

Reason for the Change: To encourage party members to engage, be informed and to participate in party affairs throughout the year, not only at the annual convention.

5th Bylaw Suggestion

Clarify JC duties on Recall petitions

Proposed Change: Strike existing VII.D.2 and addition of VII.D.2, 3, 4, 5, 6:

VII Executive Committee

D. Recall

2. If a recall petition is submitted, the Judicial Committee shall verify its authenticity, investigate the matter, and render a decision no later than 30 days after the verification of the petition. A 2/3 vote of all Judicial Committee members is required to remove an Executive Committee member.

2. If a recall petition is submitted, the Judicial Committee shall verify whether it meets the criteria of section 1 within 7 days of receipt.

3. If the petition is verified, the Judicial Committee shall determine if any of the reasons specified in the petition rise to the level of removal, investigate the matter, hold a hearing if necessary, and render a decision within 30 days of the verification.

4. If the committee deems it appropriate, it may, with a 2/3 vote, temporarily suspend the voting rights of the Executive Committee member until the matter is resolved.

5. A 2/3 vote of all Judicial Committee members is required to remove an Executive Committee member.

6. The Judicial Committee shall provide a written decision to the interested parties and for state party records.

Reason for the Change: To clarify the JD's roles and powers in a recall.

Add Comms and JC to policy manual

Proposed Change: To include communications and media policies and judicial committee procedures to the policy manual required in Section VII.C.3:

VII. Executive Committee

C. General Provisions

3. The Executive Committee shall maintain a Policy Manual. The manual shall include all rules that govern the Executive Committee not specified within the Bylaws or Rules of Order; The Party's standard operating Procedures; Communications and Media Policies; Judicial Committee Procedures; and any other information deemed necessary by the Executive Committee.

Reason for the Change: To make consistent references to policy manual contents across the bylaws.

8. JC to Establish Written Procedures for Handling Petitions

Proposed Change: Addition of IX.G.5:

IX. Standing Committees

G. Judicial Committee

5. The Judicial Committee shall provide procedures for submitting petitions, conducting investigations, rules for hearings, and other matters deemed necessary for committee operations for the state party's policy manual.

Reason for the Change: To provide a procedural guideline for the JC to follow when handling petitions for the purpose of ensuring due process of grievances.

If, after an election for officers has ended, one (or more) officer position(s) remain vacant (for example, in the case of None of the Above being elected to a position), the eligibility requirements under Article V, Section C and Article VI, Section B may be suspended to expand the pool of eligible nominees to include all party members in good standing present at convention, at which point a subsequent election for the still-vacant officer position(s) may be held.
